Description (only what you observed; size relative to other species present; posture, body shape & proportions; colors & patterns of plumage; bill, eye, & leg characteristics; other features relevant to this individual):

A medium-sized raptor with fairly long wings. As mentioned above, appeared to be molting as several of the flight feathers were missing or displaced. What was most distinct was the all black, squared tail which contrasted with the uniform grey of the body and head, without markings, although it may have been graded lighter towards the head. The wings were a darker grey, but lighter than the black tail. The secondaries were somewhat translucent when overhead. The wings were generally pointed but somewhat bent.

Behavior (Be as specific as possible about what the bird was doing):

The bird was flying rapidly north, parallel to the Delaware River. There was no deviation in course or height during the sighting. The flight was somewhat buoyant. Overall the sighting was relatively short, maybe 45 seconds to a minute in total, but less where it was in a range to pick out details, as the bird was moving fast.

Separation from Similar Species (How you eliminated others):

At first glance, when silhouetted, my initial instinct was Osprey, which are common at this location, and I observed one later that day. However, it was smaller than an Osprey, had a different look when it approached, and of course lacked the patterned wings and tail, facial markings, and white belly of the Osprey. It lacked the long broad wings of Buteos, and the short rounded wings of Accipiters. Another thought was possibly a Peregrine Falcon, but it certainly lacked any facial markings characteristic of falcons. The flight style, particularly the buoyancy, was somewhat reminiscent of a gull, as well as the size, but the plumage, especially the all black tail does not match any of the local gulls, and it lacked the large bill of a gull, which I had not seen at the site for a month at that point.

Discussion (Anything else relevant to the observation that will aid the committee in evaluating it): Around the same time there had been other reports of Mississippi Kites in southeastern Pennsylvania and New Jersey, including as close as Northampton County, within 15 miles.

Despite this being my first sighting of this species, I have a high degree of confidence in my identification based on the plumage, shape, and flight pattern that I was able to see. As detailed above, I am certain that it was none of the other species I discussed.
