Following is a report to the PORC of a Black Rail that I saw in Cumberland County.

Date of sighting: 10/16/2011

Date of report: 10/18/2011

Place: The Mountain Road Marsh of State Game Lands 169

Habitat: A mixture of open water, grasses, and cattails

Time: Approximately 12:45 p.m.

Weather: Mostly sunny, high in the sky and behind me at the time of the observation

Bincoluars: Vortex Viper 8 x 42

Notes taken in field: Yes

Previous Experience with species: None, but I have seen a number of Virginia, Clapper and Sora Rails

Narrative: I was at the marsh following up on a report from Matt Sabatine earlier in the day of a Nelson's Sparrow that he had located at the marsh. I was slowly making my way down a center elevated path that splits that marsh pishing up birds in search of the sparrow. I was looking toward the south when I turned and caught sight of a very small all dark rail, approximately 15 yards from me, with a some chestnut brown from the top to middle of its back as it fluttered and then glided down into an wet grassy area approximately 50 yards from me. I do not remember seeing any white spotting. Of course, lighting, distance and length of observation might account for that. I observed the bird for no more than 5 seconds in the air through my binoculars as it moved from my left to my right (south west to north east) an away from me. The impressions that I came away with and that I jotted down were, "Very small dark rail, smaller than a Sora, chestnut brown on the back." The bird was angled, not horizontal while in flight so it afforded me a good look at its back. I spent some time trying to relocate the bird but with no luck. I called other local birders Ramsay Koury, Andrew Markel, Matt Sabatine and Chad Kauffman, to discuss with them what I saw and to determined if there was another reasonable possibility of this bird being anything but a Black Rail. In my discussions with them I could not, and since then having looked at field guides and searching the internet cannot come up with any other reasonable explanation.
