Observation: I watched the bird for about 30 minutes, through the binoculars and the scope, from a distance of about 25 yards. The bird was a rather large, long-legged shorebird, somewhat larger than a Greater Yellowlegs. The head and neck were tan color, the body was white, and the wings were black with a large white patch on each of them. The bird had a long bill that was curved upward.
