yesterday was seen again by Lee Carnahan and briefly by others. The two

Baird's Sandpipers that have been present in Little Yellow Cove for about a

week were also still there.

While we were birding in Armstrong County, I received a phone call from Tom

Simmons who was canoeing at Yellow Creek. Fifty Hudsonian Godwits flew over

the park; 4 landed on the point west of the swimming area. Also present

were one Wilson's Phalarope and one Black-bellied Plover. Lee Carnahan is

planning to canoe from the north shore to see if he can relocate any of these species.

BTW, our little fall-out near Elderton in Armstrong County included 14 species of warblers plus a Brewster's, both cuckoos, and a Yellow-bellied Flycatcher.
