After careful review and much discussion, we regret that we are unable to accept this record. The committee felt the description of the adult bird did not rule out the possibility of a Bridled Tern and the immature individual could have been a Black Tern. This does not mean of course that the birds were not Sooty Terns, merely that the details did not allow for a definite determination.

We hope that this does not discourage you from submitting documentation on any rare birds you find in the future. Please be encouraged to send as much detail as possible when submitting a report.

Sooty Tern (adult and immature)

On Sept. 7, 1996, at 8:15 a.m., the day after Hurricane Fran, I was driving north on 176 when I saw two large terms (almost the size of Royal Terms) flying from left to right just over my car. I pulled over and tried to ID them with my binoculars. All I could see were dark upper wings as they were flying away over the Schuylkill River. I pulled out my scope to get more details, hoping they would turn around, but they didn't.

I took the bypass to get to the Gibralter pridge. I jumped out and looked up and down the river, but no terns. Then I heard some terns calling. I looked up river and the two terns were about to fly over me. The first tern was an adult Sooty Tern. I saw the dark upper wing, the white underwing, belly and forehead, the black line running through the eye and the black bill. And I also noticed the deeply forked tail. I then moved on to the second bird, which was now directly over head. It was all dark and also had a deeply forked tail and it was the same size and shape as the adult sooty. I watched them as they winged their way down the river, both having a slow, steady wing beat but still making good time.
