During the passing of Tropical Storm/Hurricane Irene to our East. Several Birders watched the Conejohela Flats from the Overlook. About 10:00 AM a larger tern flew upriver fairly close to the shoreline at slightly below eye level. Immediately I noticed that it had a yellow/orange bill. Much less red/orange coloration than the Caspian Terns that were in the area. The bill was smaller and not as thick as Caspian Tern either. It had a more streamlined appearance than Caspian Tern but was somewhat larger than Common/Forster's Tern that were also in the area.

There was a broad dark line thru the eye that extended thru the lower crown. The forehead and upper crown were white. (No dark cap)

The tail was white with a slight fork. No tail streamers.

Notable in flight on the upper side of the wings were two darker bars running along the secondaries. The primaries above were dark. There was another dark bar on the leading edge of the wing. These darker rows of feathers stood out in flight and are not consistent with the even gray scaled appearance of Imm. Caspian Terns that are seen very regularly on the Flats in the fall.

The under wing appeared light with no significant dark coloration.

Behavior (be as detailed as possible about what the bird was doing)

Flew upriver and then across the flats toward the western (York County) side of river. After clearing the trees of Green Island, I assume it flew back down river.
