Description

I was scanning across the water with the scope when this dark bird came into view flying very fast with quick wing beats. I followed it and saw it chase after Laughing Gulls on several occasions. I quickly realized it was a jaeger but wasn't immediately sure which one because of the distance. I saw it land so I drove down the road and got closer. It was still there when I arrived and I could see the longer, narrow, grayish bill with a dark tip. It flew several times and I could see a decent amount of white at the base of the primaries on the upper and under side of the wings and at the base of the tail. The overall color was a warm brown and it was larger than the Laughing Gulls it was chasing.

Sitting on the water at times and when in flight, usually chasing Laughing Gulls

Separation from similar species (How you eliminated others)

Pomarine Jaeger was eliminated because the bill was too slender and long looking, there was too much white in the wings and tail, warmer brown overall, lack of the white crescent on the primary coverts, overall size was too small and the body wasn't heavy looking

Long-tailed Jaeger was eliminated because the bill was too long, just the tip of the bill was black, way too much white on the upperside of the wings, too much white in the tail, the warm brown color,

Discussion – anything else relevant to the observation that will aid the committee in evaluating it:

Coincidentally, this was the same day the one showed up at Prince Gallitzin Lake. Both birds probably came in with the remnants of one of the tropical systems, I think it was Hurricane Irma.




