Description: The bird was "officially" spotted on October 19, 2003. According to my wife, Pascha Ferry, the bird was around for at least a week prior. Scott Weidensaul banded (band # N22750) the bird on October 21st and confirmed it to be an adult female rufous hummingbird. The bird has been extensively photographed and video taped since then. Enclosed are a few photographs of the bird.
