On 11 November 2008, Frank Windfelder found 3 Cave Swallows at a waste treatment plant in Philadelphia. I viewed the birds on 25 Nov 2008 while birding with Carolyn Sedgwick. A large flock of swallows was at the pond consisting of  $\sim$ 130 Northern Rough-winged Swallows, 1 Tree Swallow, and 3 Cave Swallows. The Caves stood out in flight with their pale buffy throats, pale collars, buff-orange rumps, and rusty foreheads. The underparts were pale whitish with some faint darker streaking along the flanks; undertail coverts were light buffy with dark markings near the tips of the longest undertail coverts. The backs were blue-black with white scapular streaking.

The wings were brown and blue-black, with an obvious molt limit in the flight feathers. The inner portion of the flight feathers were all replaced, appearing dark blue/ black, while the outer, unreplaced primaries were paler brown and somewhat worn. This molt limit present on all three Cave Swallows indicates that all are hatching year (HY) birds.

Photos of at least one of the Cave Swallows are attached in the report.
