Martha,

Thank you for your submission of your sighting of a Black-headed Grosbeak in Hummelstown from May 3,4 & 5, 2008. The Pennsylvania Ornithological Records Committee appreciates the time and labor involved in submitting your record.

After one round of voting, the sighting was unfortunately not accepted. Although the committee members felt that the bird could have been a Black-headed Grosbeak, and that the description was suggestive of one, some members thought that there were still some reasonable doubts about the identification.

Your sighting could very well be correct, unfortunately the committee has to go by the written description and some members felt that description fell a little short of a positive identification. There was no mention made of bill color, or streaking on the breast or lack thereof which would have helped to separate your bird from a 1st year male Rose-breasted Grosbeak.

Thanks again for your report and please don't let this discourage you from future submissions. The committee depends on reports like yours to further the knowledge of Pennsylvania ornithological studies.

Greetings Nick,

Enclosed is a Rare Bird Report that I filled out for Martha Grigsby based upon one phone conversation and two emails, copies of which are enclosed.

I was notified a few days after the last sighting when the visiting Black-headed Grosbeak was mentioned in a conversation between Martha and Jan Getgood (Tom Johnson's mother). I contacted Martha and our phone & email conversations began. She seemed very familiar with her "backyard" and "feeder" birds and, consequently, aware of a different visitor. Making, at least, three visits in the course of a few days gave her, her husband Kevin, and daughter Emily opportunities to discuss and compare possible species. According to Martha they are positive with their ID as a male, adult Black-headed Grosbeak.

Hi Dick,

I enjoyed our conversation as well. Here is the information you requested.

I observed a single Black-headed Grosbeak at my sunflower feeder Saturday May 3, Sunday May 4, and Tuesday May 6, 2008, mid-afternoon each day. My husband, Kevin, witnessed the weekend visits and my daughter, Emily (age 15) saw the bird with me Tuesday.

The bird's brilliant orange/tangerine breast and sleek black head attracted our attention. Unlike the Baltimore Oriole, the black on this bird's head did not extend down the back and wings but rather formed a separate "cap." Since I am familiar with the male and female Rose-breasted Grosbeaks which frequent our feeders, and their relatively short, blunt bills, I recognized that our new guest's bill was not slender or long enough to be that of a Baltimore Oriole's. I used The Sibley Guide to Birds as a reference to identify the Black-headed Grosbeak.

Please don't hesitate to contact me if I can provide any further information. I will, of course, contact you and take a photo if there is another sighting.

Hi Dick,

Please forgive my delay replying to this email. I have two high schoolers, one graduating in two weeks, and "life" got ahead of me.

1. The Black-headed Grosbeak stayed less than 5 minutes each of the 3 visits.
2. I was 22 feet from the black sunflower feeder, at eye level, looking through a large picture window in a wall of picture windows 3 stories above ground when I saw the bird. I used binoculars to improve visual acuity, especially regarding the black head to determine whether black continued down the bird's back or was a separate "cap" from the body. It was the latter.
3. I admit I am not a very good judge of bird size. However, considering the birds that frequent our feeders, this bird was larger than Goldfinches, Nuthatches, Black-capped Chickadees, and Tufted Titmouses; smaller than Blue Jays, Mourning Doves, and Pileated Woodpeckers; and about the same as Red-bellied Woodpeckers (only with a rounder rather than elongated body) and Cardinals.

I hope this is somewhat helpful. Of course, since I have been ready with the camera at the window the Black-headed Grosbeak has not returned. I will mark my calendar for the first week of May 2009 in case this one chooses to return.


