Dear Hart,

Thank you for submitting documentation on the Brewer's Blackbird observed on 19 December 1998 during the Southern Bucks County CBC (or perhaps the documentation was passed along to us from the CBC or county compiler). After careful review, the committee regrets that it cannot accept this record. A majority of members felt that it was very likely a Brewer's but that the description, resting on the bird's general and bill size plus shorter and rounded tail, was not sufficient to eliminate a Common Grackle. The shortest Common Grackles' tails in winter are only a few millimeters longer than a Brewer's tail.

The committee emphasizes that non-acceptance does not mean that the bird was not the species reported, but rather that the committee believes the documentation submitted does not support the identification conclusively.

We hope that this will not discourage you from submitting documentation on any rarities you may find in the future.

Finally, the committee apologizes for the unacceptably long delay before all members were able to vote on the record. Circumstances beyond our control caused the problem, and we believe that we are back on a timely track.
