Hi, my name is Ben Coulter. On March 25th, about 3:00 pm, I was on the Gull Point Trail on Presque Isle State Park, approximately one-half mile from the trail-head kiosk when I decided to check a small pond surrounded by *Phragmites* where I had seen a flock of Green-Winged Teal earlier that afternoon. From the edge of the trail through the reeds, I saw a flock of about fifteen Green-Winged Teal (*Anas crecca carolinensis*) accompanied by one Blue-Winged Teal (*Anas discors*) standing on a sandbar across the water about forty to fifty feet away. Several American Wigeon were in the water nearby. I used 7x35 binoculars and a spotting scope set at 15x to observe the flock. As I swept the scope from right to left, I noticed that one of the eight drakes looked somewhat different from the others. The other drakes had the characteristic markings of the Green-Winged Teal, the vertical white bar on the flank and a horizontal black line along the wing. The odd drake lacked the vertical bar, and had a white line above the black wing line. These markings appear to suggest the Common or Eurasian Teal (*Anas crecca crecca*) Otherwise, its markings resembled the other teal. It seemed to be about the same size as well. Unfortunately, after a minute or two, the flock became spooked by my presence and I failed to relocate the teal again. Once again, I apologize for the late call last night; I thought the number was for leaving recorded messages. Thanks for your time.
